#### **P.503 NEW APPLICATIONS**

##### **SDNP/23/01646/TPO - 6 Sussex Gardens East Dean East Sussex BN20 0JF**

*Field Maple - Reduce crown by approximately 3m and remove all deadwood, insuring sufficient clearance from property to improve light access and Car Parking spaces to prevent Aphid residue dripping on cars allowing for their use.*

The committee noted that this was a repeat application which had the approval of the SDNPA Tree Officer and the parish Tree Warden.

##### **SDNP/23/01852/HOUS - 14 Deneside East Dean East Sussex BN20 0HU**

*Removal of existing old extension and conservatory and replaced with new single storey part side and part rear extension on slightly larger footprint to consist of relocated kitchen, new utility and garden room along with internal alterations.*

The committee noted that this proposal would substitute a slightly bigger side and rear extension for the existing one, and that there had been no adverse comments.
