#### P.664 NEW APPLICATIONS

### SDNP/25/00018/HOUS

Proposed erection of a side extension to the existing cottage, removal of the front conservatory, and associated works to the garage and driveway.

Location: Yescombe, Went Way, East Dean, East Sussex, BN20 0DB

The Committee noted that planning permission had been previously granted in 2012, and a further application was made in 2022. It was also noted that the property is not in a Conservation Area. The application has been through considerable pre-application discussion with the planning officers.

Action: The Council resolved to recommend approval.

#### SDNP/25/00102/HOUS

Installation of three air source heat pumps.

Location: 3 Peakdean Close, East Dean, East Sussex, BN20 0HZ

The air source heat pumps are on the front elevation.

The Committee requested it be asked for these to be put on the side elevation, and that noise mitigation be implemented to minimise impact on neighbours.

Action: The Council resolved to recommend approval subject to the mitigation actions requested.

### SDNP/25/00065/HOUS

Proposed residential annexe

Location: Longview, Michel Dene Road, East Dean, East Sussex, BN20 0HP

The committee expressed their concerns on:

Overdevelopment

- Developing right up to the boundary too close to the pavement
- Lack of sight lines for car parking off road creating a danger to pedestrians using the pavement.

The Committee noted the good design features to fit the development in with the existing property, with an improvement to the overall look.

## Action: The Council resolved to recommend the application be refused based on:

- a. Impact on Character and Appearance The proposed development is considered detrimental to the character, heritage, or visual amenity of the area through overdevelopment
- b. Traffic and Safety Issues The development could cause significant access problems and or pose safety risks, due to its close proximity to the pavement and lack of parking/turning space, hindering sightlines, and endangering footpath and road users.
